In person meeting: The Board meeting will be open to in-person attendance. To remain in compliance with the state's public health guidance and CAL- OSHA COVID-19 Emergency Temporary Regulations [8 CCR §3205], RD784 will limit in-person attendance to just 25% of the room's capacity and will require 6 feet of social distancing inside and outside the building; masks are required to be worn at all times while inside the building unless speaking behind a barrier shield. There will be no standing room allowed. If all seats are occupied, citizens will be asked to wait outside. Due to the reduced capacity, we ask that citizens be respectful of others that want to participate in person, and only be in the meeting room during the item on which they wish to comment, and then leave to allow others to participate if the seats are full.
